Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  • Social Security number and income  • credit history and transaction history  • account balances and assets	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Tasi Bank chooses to share; and whether you can limit this sharing.

What we do	
How does Tasi Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Tasi Bank collect my personal information?	We collect your personal information, for example when you:  • apply for a loan or open an account  • give us your contact information or use your credit or debit card  • make deposits or withdrawals from your account  We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only:  • sharing for affiliates' everyday business purposes - information about your creditworthiness  • affiliates from using your information to market to you  • sharing for nonaffiliates to market to you  State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account - unless you tell us otherwise.

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial or nonfinancial companies.  • Tasi Bank does not share with our affiliates	
Nonaffiliates	Companies not related by common ownership or control. They can be financial or nonfinancial companies.  • Tasi Bank does not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Tasi Bank does not jointly market.	

## Other important information

This Privacy Policy Disclosure only applies to the California region. Tasi Bank will comply with all aspects of the California Financial Information Privacy Act (Division 1.4 of the Financial Code). Division 1.4 broadly regulates the sharing of nonpublic personal information of consumers. The Bank is prohibited from disclosing any non-public personal information of a consumer to a non-affiliated third party without first having obtained the consent ("opt-in") of the consumer to that information sharing.
