For the last few years, Marati has overseen the Bank's Communications and Corporate Social Responsibility efforts. Fueled by her passion to give back to the island communities served by the Bank, she has led several international award-winning Bank of Guam projects: the Bank's Year in Review, Annual Calendar and Founder's Day of Giving.

Marati, an island daughter, is a graduate of the Academy of Our Lady of Guam (Salutatorian) and received her bachelor's degree from Vassar College.
